- Option 1 – 100% Prepayment by July 15 – Payment must be made to the school office.
- Option 2 – Biannual Payment – 50% of tuition is due to the school by July 15. The balance is due on December 15.
- Option 3 – Monthly Payment (FACTS Program) – Monthly tuition payments will be automatically deducted from your checking or savings account beginning in June through May (12 month cycle). Please refer to the Tuition Policy for more details. If you are already enrolled in FACTS, you do not need to re-enroll.
