SPORTSMANSHIP PLEDGE

The administration and staff of our parish/school, all CYO parishes/schools, and the CYO athletic office wish to make it clear that CYO sports are an educational activity. Athletes, parents, and friends must be aware of our expectations with regard to sportsmanship.

Unlike professional sports, as spectators at an athletic event, we are part of the activity, much like the athletes, coaches, and officials. As a participant, (spectator or team member) we expect that you will maintain good sportsmanship or refrain from attending CYO athletic events.

- As participants and spectators, we will support in a positive way our own team remembering that the athletes, coaches, and officials are not perfect and will make mistakes. Negative, derogatory cheers or actions aimed at either team are not acceptable in educational athletics.
- You will accept the decisions of the officials without vocalizing disagreement. Officials are an important part of this educational activity. We are sending the wrong message when we challenge or abuse the game official sent to the game to administer these educational activities.
- We will respect one another, adults and athletes alike. This especially includes our opponents and officials without whose involvement, sport contests would not occur.
- The Sportsmanship Disciplinary Policy will be applied to those who are removed from a contest either by rule or for a lack of sportsmanship.

SPORTSMANSHIP DISCIPLINARY POLICY

Sportsmanship, a fundamental part of Christian ethics and morals, is expected at all levels of competition in the Monroe County Catholic Youth Organization. Acts of unsportsmanlike conduct toward anyone in the program will not be tolerated and will be dealt with harshly.

To deter unsportsmanlike behavior the league director, when deemed necessary, will enforce the following disciplinary program. This policy will be strictly enforced for all cases of ejection from a game or facility by anyone in attendance including, but not limited to, players, coaches, parents or spectators. This policy will apply before, during and/or after any event.

1. First Offense: Person(s) involved will not be in attendance at the next scheduled contest of their respective team.
2. 2nd Offense: Person(s) involved in a second offense shall be suspended from further participation, and attendance, in any Monroe County Catholic Youth Organization event for a period of one calendar year from the date of the 2nd offense.
3. 3rd Offense: Person(s) involved in their third offense shall be banned for life from any participation, and attendance, in any Monroe County Catholic Youth Organization event.

At the time the league director is notified of the unsportsmanlike event, the actions will be verified by the schools involved and documented. A letter will then be sent informing the athletic director of the offending parish of the incident, individual(s) involved and the appropriate disciplinary action to be enforced. It is the offending parish's responsibility to see that the penalties are enforced.

All disciplinary decisions by the League Director are final.
