

Frequently Asked Questions

Do I have to participate in this program?

No. This plan is offered purely as a convenience, especially to those who make many of their payments electronically or on-line.

What time of the month will the withdrawal be made on my account?

Semi-monthly debit transactions will automatically take place on the 1st and 15th of each month (or closest banking day). All monthly transactions will be withdrawn on the 1st of the month.

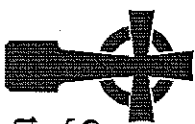
How will I show my children the importance of giving to the church if I'm not putting an envelope in the collection basket every week? Our offering envelopes have a place to check saying that you give electronically.

Do I have to enroll now? You can enroll at anytime by contacting the parish office. Please allow 3-4 weeks for automatic transactions to begin.

May I use my credit card? No. This program is being restricted to debit transactions from checking accounts only.

How can I change the amount of my offering? By calling the Parish Office (459-4662) at least one week in advance of the withdrawal and speaking directly to Dawn Olney or Bill Bauman.

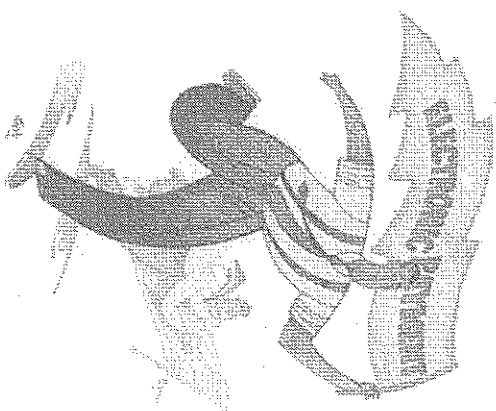
If my account becomes overdrawn, how can I stop a withdrawal from taking place? By calling the Parish Office (459-4662) as soon as possible before the withdrawal takes place and speaking directly to Dawn Olney or Bill Bauman.

About Electronic Giving

The St. Thomas Automatic Offering Plan is a safe, convenient, and reliable way to make your contributions using electronic transfer. Similar to programs offered by banks, telephone, insurance and utility companies, your contributions are automatically withdrawn from a regular checking account at any bank or credit union. It's 100% safe and you can cancel or change your contributions at any time. Best of all, it saves you time, and helps us keep our budget on track through the year.

This new program is meant to be a convenience to parishioners who choose to participate. The benefits to you are:

- ⊗ **Commitment.** Helps you give your first fruits instead of what is left over.
- ⊗ **Consistency.** Insures that your vital contribution makes it to church even when you can't.
- ⊗ **Simplified.** No checks, no envelopes, no stamps. Hassle free, as you don't need to write checks.
- ⊗ **Flexible.** Allows you to change your amount anytime.
- ⊗ **Convenience.** Gives you an easy and direct way to make your stewardship contribution.

How the Program Works

If you decide to take part in the program, it would work like this...

1. You will fill out the adjoining form and return it to the parish office by mail or in your weekly envelope. *Be sure to attach a void check to the enrollment form. We will be unable to process your enrollment without it.*
2. Parish staff will input your request and contact the necessary financial institutions.
3. Your contributions will be electronically withdrawn from your account and deposited into the parish account on the 1st of each month (and on the 15th if you chose semi-monthly contributions).
4. You will simply mark the box on the offering envelopes indicating that you have selected to give electronically.
 - I gave electronically.

Please note: This program is only for regular offertory contributions. Contributions for the "Renewing Our House of Faith" capital campaign or other special collections will continue to be made by writing checks and enclosing them in the special envelopes.
